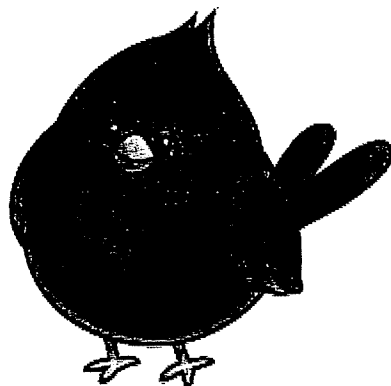

FALL RESTART PLAN INFORMATION

[Revised 8/17/2020]

The following information is temporary. It will be in effect during the Pompton Lakes Public Schools Restart Plan/Schedule.

Preschool [Lakeside]

Schedule:

The Preschool Program's schedule will remain the same, during the restart:

~Monday – Friday

~7am – 6pm

Tuition Rates:

The rates for the Preschool Program will remain the same during the restart:

~\$34.00/day (1/2 day rates available)

Drop off:

~There will be no parents/visitors allowed in the building.

~Bring your child to the Front/Main Entrance [Lakeside Avenue/Front right corner], call the Day Care phone number [973-248-8225], and a staff member will come and check in your child.

~Children will be checked temperature, and parents will be asked a series of screening questions.

**It is recommended that Preschool parents avoid dropping off between 8am and 8:30 (Lakeside Middle School reporting time)

Pick up:

~Parents picking up, between 9am and 12n, should go to the Van Ave Entrance [half circle drive] and call the Day Care number [973-248-8225].

~Parents picking up after 12n should go to the Lakeside Avenue entrance and call.

Snacks/Lunch:

~During the restart, the Day Care will not be able to provide food and drink. All preschoolers should bring morning snack, lunch, and afternoon snack as well as a refillable water bottle.

Supplies:

~Children must arrive wearing a mask. We recommend sending a spare mask in their box.

~As per Day Care guidelines, we will be asking that each preschooler bring their belongings in a plastic container, with a lid. We ask that the container be big enough to hold their food, change of clothes, small blanket (throw), and their jacket.

~We are asking that parents send a pair of slip on shoes [cros, slip on sneakers, *NO flip flops] to be kept at the day care to wear indoors.

Symptoms for exclusion:

~Please be aware of the symptoms with which your child should stay home, and for which you will be asked to pick up your child*: Fever, cough, shortness of breath, chills and/or shaking, muscle pain, headache, sore throat, new loss of taste or smell, fatigue; congestion, nausea, vomiting, diarrhea.

*Please have an emergency person who can pick up your child quickly, as they will be required to be isolated in a separate room.

The following information is temporary. It will be in effect during the 5/3/21 phase of the Pompton Lakes Public Schools Restart Plan/Schedule.

After School [Lincoln & Lenox]

Schedule:

The school-age programs will operate with the following changes to our schedule, during the restart:

~BEFORE SCHOOL CARE will be available Monday-Friday/7:30am – 9am.

~After school care will be offered Monday – Friday from dismissal (1p) – 6pm.

Location:

~The children will be divided into groups of 10-15.

~The groups will be located in designated areas of the gym. Additional space will be decided upon, if necessary.

Tuition Rates:

~Monthly rates for this phase of the restart (5/3/21) will be:

5 days/week\$340.00/month

4 days/week.....\$300.00/month

3 days/week.....\$260.00/month

2 days/week..... \$180.00/month

1 day/week.....\$90.00/month

~on Demand.....\$25.00/day

Pickup Procedures:

~No parents/visitors will be allowed in the school buildings.

~Parents can pick from the gym doors, or the playground gates. Parents can call Denise C at 201-316-0718 to have their children brought to the door/gate.

Lunch/Afternoon Snack:

~During the restart, the Day Care Staff will not be able to serve/prepare food and drink. All day care children should bring a lunch, snack, and refillable water bottle from home. Unfortunately, the staff will not be reheating food during the restart. *Please be aware that the school's "Grab and Go" lunches are often "heat & eat".

Virtual Learning:

~The day care staff will be facilitating the virtual learning set forth in the Pompton Lakes Public School's Restart Plan.

~Please have your child bring their school assigned device to Day Care.

Supplies:

~Children will be required to wear a mask. We recommend that each child carry a spare.

~The toys and games available for the after care kids will be sorted and limited to those that can be properly cleaned after every use.

~Sharing of toys will be limited and supervised.

~We ask each child to bring a pencil box containing their own pens, pencils, crayons, markers, scissors.

Miscellaneous:

~Please be aware of the symptoms of COVID, and understand that we are required to isolate and send home any child that presents with symptoms during the afternoon.

~Please keep the PLDC Staff (and school) advised of any travel, house guests, or infected family members.

~Please provide us with an emergency contact person who can pick up the child promptly, if necessary.

*It is very important that we know who is expected in after care each day, BEFORE dismissal. We are limiting our group sizes, and will need to make necessary adjustments to our lists in advance. Thanks
